



## Memorandum of Understanding

This MOU (hereinafter referred to as “Agreement”) is entered into on this 20th day of February, 2025 between;

**And**

**ISO Degree College** situated at III Floor, Sharafi Complex, Tarnaka, Secunderabad, Telangana 500017; (hereinafter called the ‘**Institution**’).

### **WHEREAS;**

- A. The Institution was contacted by the Trust to provide Free Training and Placement to Min. 20 candidates / Max 50 candidates in the field of CRM (Customer Relationship Management).
- B. The Trust, after a thorough consideration of the profile and expertise of the Institution and also taking into consideration its requirement of expertise in the above course, is desirous of engaging the Institution.
- C. Trust hereby engages with the Institution to work together under Bajaj Finserv Project subject to the following terms and conditions.

**Now this Agreement is witnessed as follows:**

### **1. DURATION OF THE AGREEMENT**

This Agreement shall come into force on 20th February, 2025 and shall be valid till 20th of March, 2025.

### **2. ROLES AND RESPONSIBILITIES**

#### **2.1 Roles and Responsibilities of Institution**

- To take all responsibility in executing the Training.
- To provide the necessary documents to the Sambhav foundation during the training process. Documents list: -Aadhaar Card, 1 Photographs & Education certificates(Xerox).
- To allow the officials of Sambhav Foundation to visit the training location.



- To make all arrangements for training.
- To maintain a track record of training and submit it whenever required.
- provide Training candidates as per the SOP.

## **2.2 Duties and obligations of Sambhav: -**

- To provide content.
- To do branding.
- To provide training facility infra.
- To provide trainer.
- To maintain candidate's records.

## **3. Termination**

- This MOU can be terminated by either party at any time upon giving the other party 7 days' prior written notice.

## **4. Governing Law and Arbitration**

This MOU shall be governed by and in accordance with Arbitration and Conciliation Act, 1996 of India as in force or as amended from time to time. The courts of Bangalore shall have exclusive and sole jurisdiction over any disputes, differences or questions arising out of or in connection with or relation to the terms of this MOU. The Arbitration proceedings shall be conducted and recorded in English by a single Arbitrator, mutually appointed by both the Parties in accordance with the said rules. The decision of such Arbitrator shall be written, reasoned, final, binding and conclusive on the Parties and judgment thereon may be entered in any court having jurisdiction over the Parties and the subject matter hereof. Arbitration expenses shall be shared equally between the Parties.

## **5. Modification of MOU**

Any modification of this MOU or additional obligation assumed about this MOU shall be binding only if Partner provides communication with regard to such change to SF.

## **6. Severability and Amendment Clause**

If any provision of this MOU is held invalid, in whole or in part, such invalidity will not affect the remainder of such provision or the remaining provisions of this MOU.

## **7. Amendment**

No amendment or change hereof or addition hereto shall be effective or binding upon any of the Parties hereto unless the same is reduced in writing with specific reference to this Agreement and executed by the Parties hereto.
