MEMORANDUM OF UNDERSTANDING

Between

KC Pullsiah Foundation

And

ISO Vocational College

This Memorandum of Understanding ("MOU") is entered into on this 16th day of December, 2024, by and between KC Pullatah Foundation (hereinafter referred to as "KCPF"), having its registered office at 6-3-348/7&, Dwarakapuri Colony, Punjagutta, Hyderabad, Telangana - 500082, and ISO Vocational College (hereinafter referred to as "ISO College"), having its registered office at House No: 12-13-1275, adjacent to Spencers, Tamaka, Secunderabad, Telangana 500017.

1. Objective:

The purpose of this MOU is to establish a collaborative partnership between KCPF and ISO College to provide 100% free training and placement opportunities for the students of ISO College, ensuring successful employment upon completion of the program.

2. Responsibilities of KC Pullaiah Foundation (KCPF):

- 2.1 KCPF shall provide 100% free training to the students of ISO College.
- 2.2 The training program will have a duration of three (3) months.
- 2.3 KCPF shall ensure 100% placement assistance for the students who successfully complete the training program.
- 2.4 The salary range for placed students will be between INR 12,000 to INR 18,000 per month.

3. Responsibilities of ISO Vocational College:

- 3.1 ISO College shall identify and nominate eligible students to participate in the training program provided by KCPF.
- 3.2 ISO College shall provide necessary support and cooperation to KCPF to facilitate smooth implementation of the training and placement program.

3.3 ISO College shall ensure that the nominated students meet the minimum eligibility criteria set forth by KCPF for the training program.

4. General Terms:

- 4.1 This MOU shall be effective from the date of signing and shall remain in effect for a period of 3 months, unless terminated earlier by mutual agreement of both parties.
- 4.2 Either party may terminate this MOU by providing a written notice of thirty (30) days to the other party.
- 4.3 Both parties agree to resolve any disputes arising out of this MOU amicably through mutual discussions.
- Confidentiality: Both parties agree to maintain the confidentiality of any proprietary or sensitive information exchanged under this MOU and to use such information solely for the purposes outlined herein.

6. Miscellaneous:

- 6.1 This MOU does not create any legal obligations or binding commitments beyond the scope of this document.
- 6.2 Any amendments or modifications to this MOU shall be made in writing and signed by both parties.
